GENERAL TERMS AND CONDITIONS FOR THE POST OF SUPERVISOR
/OPERATOR

1. The above post is purely on contractual basis for a period of 12 months (extension can be given till completion of the project, subject to satisfactory of their performance) and the selection will be done through viva-voice and computer skill test. **Application in sealed envelope along with required documents will be received on or before 04/08/2023 in the Office of the Directorate of Disaster Management, Govt. of Arunachal Pradesh, Daying Ering Colony, ESS Sector, Itanagar-791111.**
2. He/she would not be entitled to any claims, right, interests or further benefits in terms of regularization or consideration for further appointment to the said post or any other post under the Directorate of Disaster Management.
3. No Earned Leave is permissible during the contractual period except Casual Leave as per Central Civil Service rule.
4. During contract service, he/she is not entitled for medical reimbursement, winter allowances, children's education allowances, and reimbursement of tuition fee, leave travel concession, special compensatory allowances etc.
5. His/her services shall stand automatically terminated at the expiry of contract period.
6. Notwithstanding anything contained herein above, his/her services may be terminated at any time by the competent authority of the Disaster Management, if:
 - a. He/she is found to be guilty of any insubordination, intemperance or other misconduct or of any breach or non-performance.
 - b. If it is proved beyond doubt that the Department has incurred loss/damage due to his/her wilful act by way of theft, pilferage, damage etc. of any of the movable or immovable property of the department.
 - c. If he/she is incapable of discharging the duties upto the desired level assigned to the post for which he/she is bound to do according to demand of the job.
7. The appointment will stand cancelled in case he/she is employed in any government department.
8. The contract service is subject to termination at any time without assigning any reason thereof.
9. Other terms and conditions of the contract service, which are not specified herein, shall be governed as per orders/instructions issued by National Disaster Management Authority (NDMA)/State Government from time to time.
10. **Name of the short listed candidates, time and venue for the viva voice and computer skill test will be published in the office Notice board and website <https://sdma-arunachal.in/> . Candidates are, therefore, advised to visit the website regularly for any update on the recruitment process.**
11. No individual call letter for viva voice will be issued to any candidates.
12. Preference shall be given to APST candidates as per reservation policy of the govt, however, it is subject to satisfactory fulfillment of requisite educational qualifications and skill test.
